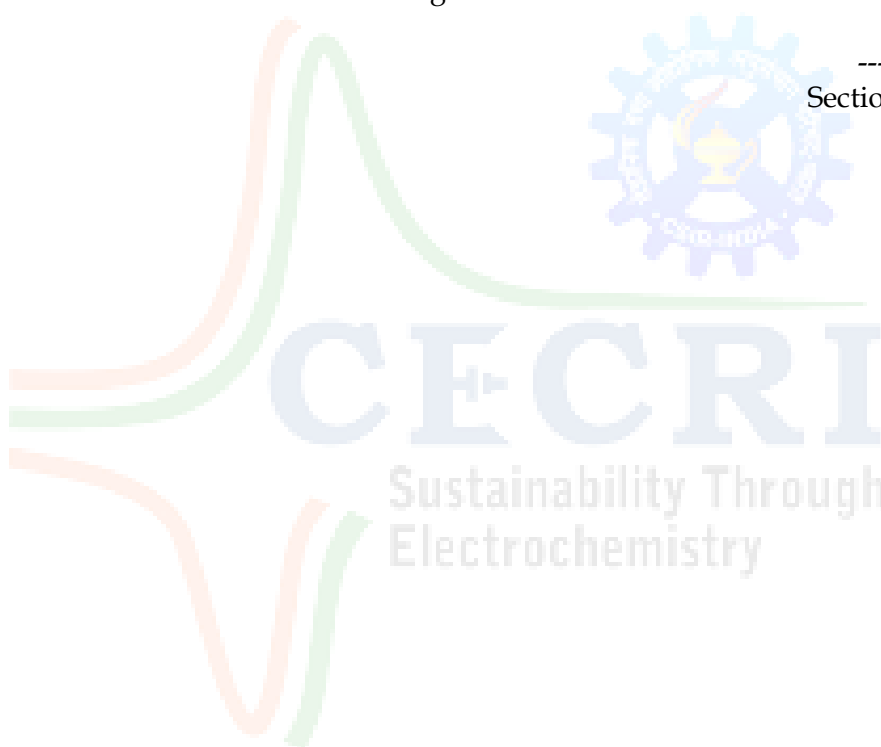

5. If at any stage, later on, the particulars furnished by the candidate are found to be wrong or incorrect or incomplete documents, his/her engagement shall be terminated with immediate effect and necessary action will be taken against them as per rules.
